City Administrator Greer discussed the appointment of Shane Bryant for Community Redevelopment Authority Committee.

City Administrator Greer discussed the Easement from Harry and Constance Stienike and Midwest TRRR LLC to the City for utilities. This will allow the city to do work on the drainage for 4th Street.

Richeson moved, Buddenberg seconded, to approve the Easement from Harry and Constance Stienike to the City for utilities. Roll call vote: Yea –Kennedy, Buddenberg, Richeson, Colwell. No – none. Motion carried.

Kennedy moved, Colwell seconded to approve the Easement from Midwest TRRR LLC to the City for utilities. Roll call vote: Yea –Kennedy, Buddenberg, Richeson, Colwell. No – none. Motion carried.

City Administrator Greer discussed Resolution 2024-19 Update Fee Schedule (airport rates for hangar rent and storage units). This will change the rate of the storage units at the airport to per square foot and language on moving permits. Small Units (0-1000 square feet) will be \$6.05 per sqft; Medium Units (1001-2500 square feet) will be \$4.15 per sqft; Large Units (2500+ square feet) will be \$3.05 per sqft. This will go in effect January 1, 2025. Greer discussed all the research done regarding rates. Mark Peterson discussed that these changes will be a lot more money and will lose renters. The council stated that they have had many discussions on rates and various options.

Kennedy moved, Richeson seconded, to approve Resolution 2024-19 Update Fee Schedule (airport rates for hangar rent and storage units). Roll call vote: Yea –Kennedy, Buddenberg, Richeson. No – Colwell. Motion carried.

Gary Mroczek discussed Ordinance 1038 Vacate 5th Street Right of way. This vacates a 20-foot strip to allow him to put up a hail structure and he will work with Shane on site triangle. Shawn Boyd discussed legal description should be path instead of patch.

Richeson moved, Kennedy seconded that statutory rule requiring reading on 3 different days be suspended for introduced Ordinance. Roll call vote: Yea –Kennedy, Buddenberg, Richeson, Colwell. No – none. Motion carried. Mayor Janssen declares motion adopted by vote of Council and statutory rule suspended for consideration of Ordinance 1038.

City Clerk Bussinger read Ordinance 1038. AN ORDINANCE VACATING A PORTION OF THE STREET OF THE CITY OF GOTHENBURG; DESCRIBING THE BOUNDARIES THEREOF; RESERVING TITLE TO SAID PORTION OF VACATED STREET; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH AND PROVIDING FOR AN EFFECTIVE DATE.

Richeson moved, Colwell seconded to approve final passage of the Ordinance 1038 with the change from patch to path. Roll call vote: Yea –Kennedy, Buddenberg, Richeson, Colwell. No – none. Motion carried.

City Administrator Greer discussed Ordinance 1039 Amend Moving permits (Section 150.081).

City Clerk Bussinger read AN ORDINANCE OF THE CITY OF GOTHENBURG AMENDING THE PROVISIONS OF THE GOTHENBURG CODE OF ORDINANCES FOR TITLE XV CHAPTER 150 RELATING TO PERMITS, REPEALING PARTS OF ORDINANCES IN CONFLICT HEREWITH AND PROVIDING FOR AN EFFECTIVE DATE.

Kennedy moved, Buddenberg seconded to approve first reading of Ordinance 1039 Amend Moving permits (Section 150.081). Roll call vote: Yea –Kennedy, Buddenberg, Richeson, Colwell. No – none. Motion carried.

City Administrator Greer discussed Ordinance 1040 Amend Sign Regulations (Section 152.056). Kennedy recommends that we table and investigate what best practice is as to whether specific size or percentage of area. No action taken.
