	***Depending on the size and complexity of the moving project, the city may deem that a commercial umbrella policy, letter of credit, or cash/check be required to cover possible public or private losses or damages. Additionally, the city may require reimbursement of any extra costs incurred to facilitate the move. The City Council shall set the cost for such requirements by resolution. If the building mover is required to interfere with the Electrical, Communication Fiber Cable, Telephone or other or telegraph poles and wires, or a gas line, the company or companies owning, using, or operating the poles, wires, or line shall, upon proper notice of at least 24 hours, be present and assist by disconnecting the poles, wires, or line relative to the building moving operation. All expenses of the disconnection, removal, or related work shall be paid in advance by the building mover licensee unless the disconnection or work is furnished on different terms as
