

**RESOLUTION 2025-3**

WHEREAS, the City of Gothenburg, Nebraska a municipal corporation and city of the second class, has determined it to be desirable to support the RYDE Transit-Community Action Partnership of Mid Nebraska; and

WHEREAS, there are federal funds available under Section 5311 of the Federal Transit Act and for the Nebraska Public Transportation Assistance Program; and

WHEREAS, the RYDE Transit-Community Action Partnership of Mid Nebraska City desires to apply for said funds to provide public transportation in the transit system's service area, which includes the city of Gothenburg;

NOW, THEREFORE, be it resolved by the City Council of the City of Gothenburg, Nebraska:

1. The RYDE Transit-Community Action Partnership of Mid Nebraska City Clerk Treasurer is instructed and directed to apply for the above-described funds.
2. Said funds are to be used for the RYDE Transit-Community Action Partnership of Mid Nebraska transportation operations in fiscal year 2025-2026 Application for Public Transportation Assistance.
3. The city of Gothenburg agrees to participate in funding the RYDE Transit-Community Action Partnership of Mid Nebraska 2024-2025 program in the amount of \$2,100.
