

RESOLUTION NO. 2025-4

RESOLUTION DIRECTING THE SALE OF CERTAIN PERSONAL PROPERTY BY PUBLIC AUCTION AND ESTABLISHING THE MANNER AND TERMS THEREOF.

WHEREAS, the Mayor and City Council of the City of Gothenburg deem the personal property hereafter described to be excess and no longer of use or benefit to the City of Gothenburg; and

WHEREAS, the Mayor and City Council of the City of Gothenburg deem it appropriate to offer for sale the property hereafter described by sealed bid;

NOW THEREFORE BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF GOTHENBURG, DAWSON COUNTY, NEBRASKA AS FOLLOWS:

Section 1: Personal property described on attached Exhibit A shall be sold to by sealed bids which shall be due by 2:00 p.m. on March 26, 2025 at the office of the City Clerk, at which time they shall be opened and read at the City Council Chambers.

The purchase price shall be paid in cash or certified funds on the date of such purchaser is given possession of the personal property, which shall occur from time to time within 60 days from the date of this resolution.

Section 2. The City Council reserves the right to reject any and all such bids with or without cause.

Section 3: The personal property described above shall be sold "as is", with no warranties, whether expressed or implied.

Section 4. An Ordinance confirming this sale shall not be required.

Section 5. A copy of this resolution shall be posted and labeled as "Notice of Sale" in three prominent places within the city of Gothenburg. Such sale of property shall not occur until 7 days after the posting of this resolution.

Section 6. Notice of said sale shall be published in a legal newspaper one time prior to the sale.
