

ORDINANCE 1045

AN ORDINANCE OF THE CITY OF GOTHENBURG AMENDING THE PROVISIONS OF THE GOTHENBURG CODE OF ORDINANCES FOR TITLE V CHAPTER 51 ADDING REQUIREMENTS RELATED TO PROVISION OF ROLL OFF BOX SERVICE IN THE CITY AND REQUIRING A PERMIT, REPEALING PARTS OF ORDINANCES IN CONFLICT HERewith AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF GOTHENBURG, NEBRASKA AS FOLLOWS:

Section 1. Title V, Chapter 51, is hereby amended by adding the following sections to the Gothenburg Code of Ordinances to read as follows:

“§ 51.26 ROLL OFF SERVICES ONLY; PERMIT REQUIRED; EXEMPTION FROM FRANCHISE REQUIREMENT.

- (A) It shall be unlawful for any person, firm, or corporation who limits its service under this Chapter, to providing roll off box or dumpster service in the city without obtaining a permit set forth in subsection (B) hereof.
- (B) Prior to offering roll off service in the city an applicant shall complete a permit application and file the same with the City Clerk.
The application shall require the following information:
 - 1. Name of business.
 - 2. Name of all beneficial owners.
 - 3. Physical and mailing address of the company.
 - 4. Name of person to contact and telephone and email information.
 - 5. Proof of insurance with the City of Gothenburg as a covered entity providing \$500,000 injury coverage; \$100,000 property damage coverage.
 - 6. The applicant shall pay an annual fee of \$100 to the Gothenburg City Clerk.
 - 7. The permit shall be valid from January 1 to December 31 and shall not be prorated.
- (C) Any company granted a permit to provide only roll off box service in the city shall not be subject to the requirements of Section 51.03 or Section 51.21 hereof.
- (D) Any person or firm violating this Section shall be guilty of a misdemeanor and shall be subject to a fine of \$200.
- (E) A permit holder under this Section is subject to all applicable terms and conditions of this Sub Chapter 51.
- (F) A permit holder shall comply with weight, height and size limits established by state and federal laws and regulations.

Section 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 3. This ordinance shall become effective upon its passage, approval and publication according to law.
